ACCEPTANCE OF RISK AND INDEMNITY IN RESPECT OF USE OF PRIVATE PROPERTY AS AIRCRAFT LANDING GROUND (the “Sabi Sabi Airfield”)

I/We, the undersigned, acting on behalf of and duly authorised by:

the Owner and/or Operator of certain aircraft specified below (the “**Aircraft**”) hereby acknowledge that I/we, on my own behalf and on behalf of the Owner and/or Operator, will use the private airstrip and/or aerodrome situated on immovable property belonging to Loodswaai (Pty) Ltd. (“**Loodswaai**”) and operated by African Cultural Tours (Pty) Ltd. t/a Sabi Sabi Private Game Reserve (“**Sabi Sabi**”) being the Sabi Sabi Airfield, for the purposes of landing, parking and takeoff entirely at my/our own risk.

By entering and/or landing at the Sabi Sabi Airfield I/we hereby agree that:

- **I/WE ENTER THE SABI SABI AIRFIELD AND/OR USE ANY OF THE FACILITIES AT THE SABI SABI AIRFIELD (‘FACILITIES’) VOLUNTARILY AND ENTIRELY AT MY/OUR OWN RISK.** I/We specifically agree that none of the owner, Loodswaai and/or operator (i.e. Sabi Sabi) of the Sabi Sabi Airfield, its agents and contractors (collectively the ‘**Indemnified Parties**’) will be liable for any loss, damage, injury or liability of whatever nature and howsoever arising (including negligence) which I/we, or my/our dependents and/or my/our guests and/or my/our property (including without limitation, the Aircraft) may suffer as a result of the use of the FACILITIES and/or entry to the Sabi Sabi Airfield.
- **I/WE SPECIFICALLY AGREE THAT IF AND TO THE EXTENT THAT I/WE OR MY/OUR DEPENDENTS MAY HAVE A CLAIM (OF ANY NATURE IN LAW OR IN FACT) AGAINST THE INDEMNIFIED PARTIES, I/WE WILL NOT PURSUE THAT CLAIM AND INSTEAD WILL HOLD THE INDEMNIFIED PARTIES HARMLESS IN THAT REGARD.**

I/WE ACCEPT FOR US/MYSELF AND MY/OUR DEPENDENTS THE FULL RISK ASSOCIATED WITH MY/OUR USE OF THE SABI SABI AIRFIELD AND/OR USE OF THE FACILITIES AND HEREBY WAIVE ANY AND ALL CLAIMS I/WE OR MY/OUR DEPENDENTS MAY HAVE IN LAW AGAINST THE INDEMNIFIED PARTIES’.

I/WE FURTHER INDEMNIFY AND AGREE TO HOLD THE INDEMNIFIED PARTIES HARMLESS AGAINST ANY AND ALL LOSS, DAMAGE OR LIABILITY (OF WHATEVER NATURE) ARISING DIRECTLY OR INDIRECTLY OUT OF OR IN CONNECTION WITH ANY CLAIM, DEMAND, CHARGE, ACTION OR CAUSE OF ACTION (OF WHATEVER NATURE) AS A RESULT OF MY/OUR OR MY/OUR DEPENDENT’S USE OF THE FACILITIES AND/OR THE USE AND/OR ENTRY TO THE SABI SABI AIRFIELD.

I/WE ACKNOWLEDGE FURTHER THAT THE SABI SABI AIRFIELD IS LICENSED AS A CATEGORY 2 UNDER THE CIVIL AVIATION REGULATIONS 2011, AS AMENDED.

I/WE ACKNOWLEDGE THAT I/WE AM FAMILIAR WITH THE MEANING AND IMPACT OF THE AERODROME’S RATING AND CATEGORIZATION AND HEREBY AGREE THAT MY/OUR USE WILL COMPLY THEREWITH.

ACCEPTANCE OF RISK AND INDEMNITY IN RESPECT OF USE OF PRIVATE PROPERTY AS AIRCRAFT LANDING GROUND (the “Sabi Sabi Airfield”)

The Sabi Sabi Airfield is unfenced and is not maintained and in this regard I/we specifically acknowledge that the use of the Sabi Sabi Airfield may be hazardous to the Aircraft and/or the health or bodily integrity of their occupants. We acknowledge that Sabi Sabi will require a copy of my/our Operators “Risk Assessment” as undertaken by the safety officer of the relevant Aircraft owner/operator in order to comply with applicable SACAA regulations. I/we acknowledge that neither Loodswaai nor Sabi Sabi gives any warranties, representations or undertakings in regard to the suitability of the Sabi Sabi Airfield and that the use thereof is entirely at the sole risk and responsibility of the owner/operator of the Aircraft concerned.

I/WE HEREBY INDEMNIFY AND HOLD HARMLESS LOODSWAAI AND SABI SABI AGAINST ANY CLAIMS, LOSS, DAMAGE OR ACTIONS WHICH BE BROUGHT BY ME/US OR ANY OTHER PERSONS WHATSOEVER, AS A RESULT OF OR IN CONNECTION WITH THE USE OF THE SABI SABI AIRFIELD BY ME/US.

WE UNDERTAKE JOINTLY AND SEVERALLY TO MEET ALL SUCH CLAIMS OR TO CONTEST THEM FOR OUR OWN ACCOUNT AND OUR OWN COST INCLUDING LEGAL COSTS IN THIS REGARD INCURRED BY LOODSWAAI AND SABI SABI ON AN ATTORNEY AND OWN CLIENT SCALE.

I/we undertake in favour of Loodswaai and Sabi Sabi that the contents of this document (and its indemnities) have been advised to, and accepted by, the owner, operator and insurers of the Aircraft and that each of them have agreed to waive any and all rights of recourse against Loodswaai or Sabi Sabi howsoever such rights may arise.
